1. **Call meeting to Order:** Mayor Seymore call the meeting to order at 5:31 p.m.
2. **Prayer and Pledges:** Mayor Seymore gave the invocation and lead the pledges.
3. **Citizen Presentations for Items not on the Agenda:** None
4. **Public Comment on Agenda Items other than a Public Hearing:** None
5. **Consent Agenda:**
 - a. Approve Minutes from the June 5, 2023, City Council Meeting. Mayor Seymore requested a correction on page two of the spelling of Councilmember Manley's name. Councilmember Lange made a motion to approve the minutes of the June 5, 2023, council meeting. Councilmember Manley seconded the motion. The motion carried unanimously.
6. **Regular Agenda Items for Discussion, Consideration and/or Action:**
 - a. Termination of Contract with USG (Utility Service Group, Inc.), regarding water storage cleaning and maintenance. Councilmember Gray made a motion to proceed with the termination of USG's (Utility Service Group, Inc) contract. Councilmember Manley seconded the motion. The motion carried unanimously. Secretary Ross gathered signatures of all Councilmembers and Mayors on USG's termination letter.

7. City Manager's Report:

- a. Public Works Update: Streets, Wastewater, Water. Public Works Director Bowman updated the council on various street paving projects, pothole repairs and water leak repairs. Public Works staff will begin their shift one hour earlier (7:00 a.m.) due to the extreme heat this summer.
- b. Introduction of new Police Officers: Chief of Police Cornutt introduced the city's new police officers, Jacob Gehrett and Kristen New.
- c. Finance & Budget update: City Manager Frieda stated facts concerning the reduced sales tax revenue as being common to surrounding municipalities. Staff are still working on the budget. The city's accounting software provider, FundView, is working with staff and our auditing firm to streamline the general ledger.
- d. Meter Bond Update: City Manager Frieda presented communication he has had with the Texas Water Development Board in closing out the Water Meter Bond Series 2016, stating that the City may not owe any further funds, and a possibility of funds being returned to the City.
- e. The fireworks display at Bruce Field is set for June 29th at dusk. City Manager Frieda confirmed the program is on schedule.

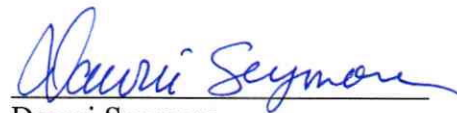

9. Executive Session: Council Adjourned into Executive Session at 6:03 p.m. pursuant to Texas Government Code.

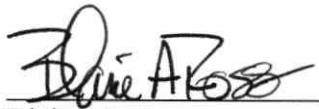
