Citizen Complaint Sworn Affidavit Form

IMPORTANT- Please read the following statement:

Under the Texas Penal Code – Sec. 37.08 False Report to a Peace Officer

(a) A person commits an offense if, with intent to deceive, he knowingly makes a false statement that is material to a criminal investigation and makes the statement to:

(1) a peace officer or federal special investigator conducting the investigation; or

(2) any employee of a law enforcement agency that is authorized by the agency to conduct the investigation and that the actor knows is conducting the investigation.

(b) An offense under this section is a Class B misdemeanor.

Under Texas Penal Code – Section 12.22,

An individual adjudged guilty of a Class B misdemeanor shall be punished by:

(1) A fine not to exceed \$2,000;

(2) Confinement in jail for a term not to exceed 180 days; or

(3) Both such fine and confinement.
