- 1. Call meeting to Order: Mayor Seymore called the meeting to order at 5:34 p.m.
- 2. Prayer and Pledges: Councilmember Lange gave the invocation and lead the pledges.
- 3. Citizen Presentations for Items not on the Agenda: None
- 4. Public Comment on Agenda Items other than a Public Hearing: None
- 5. Consent Agenda:
