



## **Homeowner's Exemption Certificate For Plumbing, Electrical, and/or Mechanical Permits**

Per Section Sec. Sec. 10-1 In General and 10-3 Contractor Registrations of the City of Ballinger Code of Ordinances:

### **Sec. 10-1 In General**

Chapter 10 Electricity of the City of Ballinger Code of Ordinances is amended to read as follows:

That the 2005 National Electrical Code, NFPA (National Fire Protection Association) and Annex G Administrative Code for the National Electrical Code, 2005 Edition, are hereby adopted by reference. Unless deleted, amended, expanded or otherwise changed herein, all provisions of such code shall be fully applicable and binding.

Sec. 10-3 Homestead Exemption Permit. (d) Homeowner's right. Nothing herein shall prohibit any homeowner from personally installing electrical conductors or equipment within his own homestead premises; providing that the owner applies for and secures a permit; pays required fees; does work in accordance with this chapter; requests inspections of his work during the process of the installation; and receives final approval of his work upon completion.
