On the recommendation of the WTCOG, Ballinger should rescind its termination and leave the agreement in place. The City will then address more local mutual aid agreements that are not marked for state or federal reimbursement. Councilmember Akins moved to rescind the termination of the Mutual Aid Agreement. Councilmember Gray seconded the motion. The motion carried unanimously.




