#### MARK MCNULTY'S UPDATE REPORT:

He submitted the 2013 racial profile report last week. Mike Herd is still in the hospital and not standing yet. Ethan Farmer was hurt in an accident Saturday night and will be on light duty only for 6 weeks. He wanted to let Council know that there will be major overtime due to being short two patrol officers.

#### **CONSIDER THE REQUEST OF ELIZABETH COOK:**

Council approved the use of the airport for the Curing Cancer dance and noted the date changed to May 2-3, 2014. Comm. Phillip Arp made the motion to approve use and date. Second by Comm. Jolene McBurney and was unanimously approved.

#### **HEAR RICKY BOWMAN YEAR ENDING 2013 REPORT:**

He went thru the City's audit trying to hit the highlights. A written report was given to everyone and he said there was no need in him reading it to you and he would go over highlights. On page 5 of report compare government activities expenses and business activities expenses for 2 years. We had an increase in net position of governmental funds and that should make up for 2012-2013 loss. We made some money in the Airport Fund and it is doing fine. The sales tax revenue is up by \$60,000.00. There has only been a \$7,000.00 increase in expenses. We had a decrease in Water & Sewer fund. Actual cash flow of city generating \$171,362.00

from operation of Sewer & Water, but principal & interest payment on debt is \$425,000.00 which makes a loss of \$253,638.00. He went over the Bond payments due each year there were some governmental changes that affected our position. It is his duty to point this out. He is working with Bonita and Debby closely on the bank reconciliation. Accounts receivable, general ledger and bank reconciliation should match to the penny. It has been close but not exactly. We are changing the invoice date to that of the invoice instead of payment due date. On the Budget, it is not matching what it was amended to. All adjustments to the Budget are not matching what is being spent and amended budget needs to be in the minutes. Steve, Bonita and Debby need to watch that closely. He is working on an agenda to get that done this year. Phillip brought up that USTI software was so complicated that we could not find the right way to get the reports they wanted to see each meeting. Rick thought it was available but Bonita needed more man power to get it all done. She runs out of time. We are facing the same problems we faced last year, that everyone thinks their water bill is too high. We need to look at property tax to raise money. He thanked us and there were no more questions for him. Comm. Phillip Arp made a motion to accept the fiscal year ending September 30, 2013 audit as presented. Comm. Darlene Kelly seconded it and it was unanimously approved.

#### **HEAR REQUEST FROM FIRE DEPARTMENT:**

Robert Langston, Clyde Kresta, Dustin Kresta and Brent Allen were present to talk about critical need assessments. A packet made by the fire department was in each agenda package. Some equipment is 15 to 25 years old. It is very expensive to fix any of it. Based on the package given to each of you the needs are in three sections. They really need to update rescue tools, buy air bags and two thermal imaging cameras. The one camera they had now is fifteen years old and it was a demo when first purchased. They have thirty two sets of equipment that are out of date and need to be replaced. They need to buy four or five sets a year at a cost of \$9600.00. They have looked at grants from many places but being so small and not having enough calls they have not received any applied for. Government has cut grants to \$294,000,000.00 and the bigger departments are getting them. We continue to use grants to send fire fighters to school for ongoing training. School is now \$690.00 per man. We send nine to school every year. The booklet was made up to go public to ask for donations. They wanted to ask the city first, to see if there were any available funds to purchase any of these items. We help the surrounding areas by loaning out our equipment over and over. The radio system needs a repeater. The communication system needs a ton of work. Just using hand held radios is impossible. They cannot use the Police Dept's channel. Clyde will call Abilene COG for repeater but it could take from six to eighteen months just to get a signal processed and mounted on our tower at a cost of \$2500.00 by Texas Communication. The fire department works on a Budget of \$104,043.00 but that includes salary, health insurance, pensions and upkeep on equipment plus gas. The County has cut in half what they were giving the department. In 2013 they had forty calls including five grass fires, but the outlook is for more fires due to no rain. We have just been lucky. But they need to be prepared in case we aren't lucky this year. It could be the difference between someone's life and is needed for our fire fighters own safety. The City Council agreed it is an awesome package, awesome work and thanked them. Comm. Phillip Arp said we have to look at the budget and that this should have been turned in September before the 2014 Budget was done. We now have an idea of what all is needed. Comm. Phillip Arp made a motion to table a request from the fire department for equipment needs. Comm. Eloyed Fuentes seconded it and was unanimously approved.

Mark McNulty reported to the Council that the police department took 53 incident reports, worked 6 accidents. They made 21 arrests including 1 dealer. There were 80 animal calls. Michael Herd will be out for another month, and Ethan Farmer's toes were not broken and he should be back to work by February 10. The Council accepted the report as presented.

### DISCUSS AND CONSIDER PLANS FOR THE ANNUAL ETHINIC FESTIVAL WITH THE CHAMBER OF COMMERCE:

Dee Dee Peterson met with the Council to give them an update of the plans for the Ethnic Festival set for April 25-26, 2014. She told the Council that she was the chairperson this year and she wanted to thank the City for all their help in the past and keep the City informed of all the plans for this year. They plan to have a parade using the same route as the Christmas parade. The route is starting on 6<sup>th</sup> Street down Hutchings, turning on 8<sup>th</sup> Street to Railroad Avenue back down to 6<sup>th</sup> Street. They plan to have a street dance on Strong Avenue behind the courthouse with a beer and wine tasting tent set up on Ballinger Feed & Seed parking lot from 7:00p.m.-10:00 p.m. on Saturday.

### REMOVE FROM THE TABLE TO DISCUSS AND CONSIDER THE USE OF CARVER SCHOOL LOCATED ON SOUTH 8TH STREET:

**Comm. Darlene Kelly** made the motion to remove the issue from the table. **Second by Eloyed Fuentes** and was unanimously approved.

Steve Nixon reported to the Council that David Gonzales has been contacted to see if he was interested in renting the Carver school instead of purchasing. Mr. Gonzales stated that he wanted to purchase the property and not rent.

Brian Campbell met with the Council to tell the Council about the future plans for this property by the Chamber of Commerce. They would like to make this area a multi-use complex with an outdoor stage and pavilion with restroom and concession facilities. They would like to put in RV hook-ups with electric and water to possibly have the Curing Cancer dance, Bar-b-que cook-off and dances for Ethnic festival. The City and the Chamber do not have the money at this time and they are looking at possibly getting private donations to make this happen.

### DISCUSS AND CONSIDER INCREASING THE WATER AND GARBAGE DEPOSITS FOR NEW CUSTOMERS:

The Council was informed that the current deposits are \$60.00 for water and \$20.00 for garbage. This is not enough to cover the final bill since we bill a month behind, and the average bill for a month is \$79.69. Therefore by the time we are informed the customer has two months billing that is due. After discussion, **Comm. Philip Arp** made the motion to pass an ordinance to increase the water deposits for new customer to \$110.00 and for garbage deposits to \$40.00. **Second by Eloyed Fuentes** and was unanimously approved.

### DISCUSS AND CONSIDER REVISING THE POLICY FOR LEAK ADJUSTMENTS AND BILL EXTENSIONS:

The Council was informed that the current policy for water leaks is to average a customer's bill three months prior to the leak, subtract the average amount from the leak usage water charge and divide the balance between the customer and the City.

The current extension policy is if a customer calls for an extension, it is granted.

After discussion, Comm. Phillip Arp made the motion to stop all leak adjustments and set up a policy that would allow a customer to have three to six months to pay off charges incurred from a water leak. They have approximately six years of water in their lake even if they do not receive any run off. Mr. Martin would like to look at the feasibility to see if the City of Coleman would be interested in selling water to Ballinger. After discussion, Comm. Philip Arp authorized Jacob & Martin to look into the feasibility for Ballinger to purchase water from the City of Coleman. Second by Comm. Darlene Kelly and was unanimously approved.

You have asked the customers to conserve water and they should not have to bear the cost for the shortage in revenue.

Cecil Walston-207 Sharp- Stated that he was at the meeting for two reasons. One was to support Officer Michael Herd, and to say that he understands the rate increase for the water because the infrastructure in out dated and it is not cheap to replace.

## DISCUSS AND TAKE ACTION ON INCREASING THE HOTEL/MOTEL TAX RATE TO 7%:

Comm. Phillip Arp made the motion to increase the hotel/motel tax from 5% to 7% effective November 1, 2014. Second by Comm. Eloyed Fuentes and was unanimously approved.

The Council discussed the contribution for rural fire protection from Runnels County. The fiscal year 2013 the County contributed \$21,000 and 2014 they only contributed \$10,500 and the \$10,500 is what they have budgeted for the 2015 fiscal year. The Council questioned how many rural fires were taken care of by the fire department and if this amount was appropriate. After discussion, Comm. Phillip Arp made the motion to table this issue until the next meeting for more information. Second by Comm. Jolene McBurney and was unanimously approved.

# DISCUSS AND TAKE ACTION ON A RESOLUTION WITH BALLINGER NATIONAL BANK ON A LOAN FOR THE PURCHASE OF A NEW PATROL CAR AND NEW SOFTWARE PROGRAM FOR THE POLICE DEPARTMENT:

Bryan reported to the Council that this loan would be to purchase a new patrol car for the amount of \$38,000.00 and the COPsync program for the patrol cars. This program would give the officers access to run licenses and car tags without having to go through dispatch. The cost for the program and training is \$28,519.90. After discussion, Comm. Phillip Arp made the motion to pass a resolution authorizing the Mayor and City Manager to sign a short term note at Ballinger National Bank for these purchases. Second by Comm. Darlene Kelly and was unanimously approved.

The airport ended up \$19,871.30 to the good.

Mr. Grimes told the Council that the restroom in the city park will have to be addressed at some time in the future. They are open to the public 24 hours per day, need to be updated and are very hard to keep clean.

Mark McNulty presented his monthly police activity report to the Council. The department activity was down from last month. They had two methylamine arrests. One officer was terminated and another one was put on three day suspension with no pay. The Council accepted the report ad presented.

### HEAR REQUEST FOR FUTURE AGENDA ITEMS FROM CITY COUNCIL:

Comm. Jolene McBurney asked about the signs that were supposed to be put up for the changing of Avenue C to Country Club Road. She was informed that the sign have been ordered and will be put up.

#### **EXECUTIVE SESSION-GRIEVANCE FOR MICHAEL HERD:**

Lance Wyatt representing Michael Herd told the Council that according to Section B of Government Code 551.074 they requested that the grievance be held in open session. Mr. Wyatt presented the Council with several items that he felt were improper procedures considering his client. He asked that Mr. Herd be reinstated to his previous position and pay effect immediately. Mr. Herd would like to put this incident behind him and get back to work. The Council needs to make the decision of what to do with the grievance.

Chief Mark McNulty told the Council that he admits to some procedural mistakes, but he still stands by his decision to terminate Michael Herd.
