 - i. Accounts Payable, Tax Revenue. City Secretary Ross presented the March reports.





1. **Call meeting to Order:** Mayor Seymore called the meeting to order at 5:36 p.m.
2. **Prayer and Pledges:** Pastor Marty Akins gave the invocation and lead the pledges.
3. **Citizen Presentations for Items not on the Agenda:** None
4. **Public Comment on Agenda Items other than a Public Hearing:** None
5. **Consent Agenda:**
 - a. Approve Minutes from the March 8th, 2024 City Council Meeting. Councilmember Morrish made a motion to approve the minutes. Councilmember Lange seconded the motion. The motion carried unanimously.
6. **Regular Agenda Items for Discussion, Consideration and/or Action:**
 - a. Fire Department Roof Repair – Steve Adams, Menjivar Roofing. Mr. Adams has materials left over from a prior job, lowering the cost of repair to \$38,500.00. Secretary Ross has spoken to Financial Advisor Martella and funding could come from a budget adjustment out of the administration budget.
 - b. TxDOT Aviation 2024 Ramp Grant Agreement. Bruce Field Manager Ellen McKinnon. Airport manager McKinnon reported the current RAMP grant funding eligible to the city for fiscal year 2024 is \$111,111.11, with a 10% payback from the city. Councilmember Gray made a motion to approve the RAMP grant application. Councilmember Morrish seconded the motion. The motion carried unanimously.
 - c. City Pool Status. Public Works Director Bowman reported the original contractor to the pool recommended to not open the pool until repairs have been completed.
